For over thirty years the Children's Leukaemia & Cancer Research Foundation (Inc) (CLCRF) has been raising funds for research into childhood cancers.

The creation of the Foundation was inspired by nine year old Jennifer Harper, who was diagnosed with leukaemia in 1977. When her father, Peter Harper, discovered that there was no research into children's leukaemia being done in Western Australia, he set out, together with other parents of children with cancer, to raise funds for this purpose. Sadly Jennifer passed away in 1978.

Thanks to invaluable and vital research over this time what was a very poor prognosis for children with some cancers has now greatly improved, many can now expect a survival rate of approximately eighty percent.



CLCRF has a commitment to ensure this ground-breaking research continues so that the future generations will be the ones to live cancer free. The Foundation relies on the generous support of the community to continue its vital research, as we do not receive State or Federal funding.

“I give to the Children’s Leukaemia & Cancer Research Foundation (Inc) the sum of \$..... to assist with research into childhood leukaemia and cancers.”

Bequests can be anonymous but letting your charity know of your kindness allows them to make plans for the future, assist you with wording the Bequest and thank you personally.

Making a Will should give you peace of mind that comes from planning ahead for those you care for - and children with cancer.
